Personal data we process

Kranendonk B.V. processes your personal data because you use our services and/or because you provide them to us yourself.

Below is an overview of the personal data we process:

- First and last name
- Telephone number
- E-mail address

Special and/or sensitive personal data that we process

Our website and/or service does not intend to collect data on website visitors who are under 16 years of age. Unless they have permission from parents or guardian. However, we cannot verify whether a visitor is older than 16. We therefore recommend that parents be involved in their children's online activities in order to avoid collecting data about children without parental consent. With what purpose and on what basis we process personal data

Kranendonk B.V. processes your personal data for the following purposes:

- Sending our newsletter and/or advertising folder
- Calling or e-mailing you if this is necessary to be able to provide our services.

Automated decision making

Kranendonk B.V. does not make decisions about matters that could (significantly) affect individuals on the basis of automated processing. This concerns decisions that are made by computer programmes or systems, without a person (for example an employee of Kranendonk B.V.) being involved.

How long we store personal data

Kranendonk B.V. does not retain your personal data longer than is strictly necessary to achieve the purposes for which your data are collected. We use the following retention periods for the following (categories of) personal data:

Sharing personal data with third parties

Kranendonk B.V. only provides third parties and only when necessary for the performance of our agreement with you or to comply with a legal obligation.

Cookies, or comparable techniques, that we use

Kranendonk B.V. does not use cookies or similar techniques.

Inspection, correction or removal of data

You have the right to inspect, correct or remove your personal data. You also have the right to withdraw your possible consent for data processing or to object to the processing of your personal data by Kranendonk B.V. and you have the right to data portability. This means that you can submit a request to us to send the personal data we have on you in a computer file to you or another organization named by you.

You can send a request for inspection, correction, deletion, data transfer of your personal data or a request to withdraw your permission or objection to the processing of your personal data to info@kranendonkbv.nl.

To make sure that the request for inspection is made by you, we ask you to send a copy of your proof of identity with the request. In this copy, black out your passport photo, MRZ (machine readable zone, the strip of numbers at the bottom of the passport), passport number and Citizen Service Number (BSN). This is to protect your privacy. We will respond to your request as quickly as possible, but within four weeks.
